

## FLAGS OF FELLOWSHIP CONTENT RELEASE

This Content Release (“Release”) is between the organization or individual providing content (“Provider”) from its Flags of Fellowship/ Banderas de Fraternidad/ Banderias da Fraternidade event and the International Fellowship of Christians and Jews, Inc. and its authorized global entities, licensees, and agents (“IFCJ” or “we”), the user of the content provided under this Release. By registering to host a Flags of Fellowship/ Banderas de Fraternidad/ Banderias da Fraternidade event, accessing, downloading, or using the electronic materials provided by IFCJ, for use at your or your organization’s Flags of Fellowship/ Banderas de Fraternidad/ Banderias da Fraternidade event, you acknowledge that you have authority to bind Provider and Provider agrees to be bound by the terms of this Release. If Provider does not agree to these terms, you and/or the Provider may not access, download, or use the electronic materials.

IFCJ is providing certain electronic materials to Provider to host a Flags of Fellowship/ Banderas de Fraternidad/ Banderias da Fraternidade event commemorating, honoring, and remembering the 1,200 lives lost in Israel on October 7, 2023 (the “Event”). If Provider provides any photographs, images, videos, statements, or any other materials from the Event (“Content”) to IFCJ, Provider acknowledges that it agrees to the terms under this Release.

In recognition of Provider’s use of IFCJ’s electronic materials and participation in the Flags of Fellowship Event, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Provider agrees to be bound by this Release.

### 1. GRANT OF USE.

Provider grants to IFCJ and its licensees, the perpetual, irrevocable, royalty-free right and permission to: (a) use, publish and republish, modify, distribute, reproduce, broadcast, transmit, adapt, display, make available, print, and post on the Internet or social media platforms, the Content, in whole or in part, in any media now know or hereinafter developed, without restriction as to changes or transformations, in any format; (b) create photographs, videos, audio recordings, or other works using or including the Content; and (c) copyright any additional or derivative works created using the Content, in the name of IFCJ (or any other name that IFCJ may determine).

### 2. RELEASE.

Provider hereby releases, discharges and agrees to hold harmless IFCJ, its employees, its legal representatives or assigns, and all persons under its permission or authority, from any and all liability, claims, demands, or causes of action that may arise from the use and publication of the Content, including without limitation any claims for defamation, invasion of privacy, violation of right of publicity, copyright infringement, breach of contract, or any other cause of action, including any third-party rights or claims that may arise from the inclusion of any third-party in the Content.

### 3. REPRESENTATIONS AND WARRANTIES.

Provider represents and warrants that it has obtained the necessary releases, permissions, and consents from any third parties who appear in the Content, and that no further consent is required for the use of the Content as specified in this Release. Provider agrees to indemnify IFCJ against any claim, lawsuit, or liability arising from the failure to obtain such permissions from any third party. Provider warrants that

the Content does not infringe upon the intellectual property rights, privacy rights, or any other rights of any third party. Provider agrees to indemnify and hold IFMJ harmless from any liability, damages, or expenses, including legal fees, arising from any claim that the Content violates any third party's rights.

#### **4. ATTRIBUTION.**

Provider understands and agrees that credit or attribution may or may not be provided on any specific use of the Content or any work using or including the Content, at the sole discretion of IFMJ.

#### **5. ENTIRE AGREEMENT.**

This Release constitutes the entire agreement between IFMJ and Provider with respect to the Content and supersedes all prior or contemporaneous agreements, understandings, and communications regarding the Content.

#### **6. GOVERNING LAW.**

This Release will be governed by and construed in accordance with the laws of the State of Illinois, without regard to its conflicts of law principles. Any disputes arising out of or in connection with this Release shall be resolved in the courts located in Illinois. Provider's obligations under this Release survive the termination of this Release.
